This does not preclude funding of programs well suited to our mandate. Funding is not provided for salaries, nor for post graduate scholarships. There is a separate and different application for higher education scholarships.

Please complete this application form and submit along with any additional information you deem necessary for our Allocation Committee by **Monday, September 27, 2010 at 4:30 p.m. Faxed applications will NOT be accepted.** All applications and supporting documents must be in the Snowshoe Foundation offices, located in the Human Resources Department of Snowshoe Mountain or postmarked prior to September 27, 1020.

The application may not exceed 10 pages, if over 10 pages, it will not be reviewed. After reviewing all applications received by the deadline, the Board of Director’s may call you/your organization representative in for an interview between the dates of October 14 and October 22. The Board will finalize allocations approximately November 3, 2010 with announcement and distribution of funds taking place on or before November 8, 2010..
